Product: Organic Dried Banana Dices

Ingredients: Dried Banana 99.5 %, Dried Banana Flour 0.5 %

Process Description: Organic Dried Banana Dices are obtained by dehydration of wholesome, clean, and suitable ripeness, banana (Musa spp.cv.) fruits to preserve colour and flavour. Organic Banana flour is a powder, made of green raw banana that is often used as a gluten free replacement to wheat flours or as a source of resistant starch. Made of sound, mature, ripe banana that have been washed, selected, peeled, cut into slices, dried, mixed with dried banana flour, metal detected & packed into Food grade poly bags.

Country of origin: Sri Lanka

Storage conditions and shelf life: 1 year shelf life under ambient temperature. (Sealed condition). Store under odour free clean cool & dry condition in sealed packs. Store on pallets, out of direct sunlight and away from walls.

Packaging: Primary packing Material – Nylon 15 Mic/LLDPE 70 Micron (Comply to US FDA regulations). Secondary packing material – 5ply corrugated cartons.
